COURTSCAPES Paint striping shall be free from peeling and under warranty for a period of **TWO (2) years** from the above initiation date.

All warranties expressed herein are contingent upon the following: 1. Installation being performed by FLEXGROUND, 2: Owner, at owner’s expense, having a maintenance FlexCoat performed at **TWO (2) year** intervals from date of substantial completion. 3. Full payment by the owner of all pertinent invoices and adherence to any required maintenance procedures, and 4. Reasonable written notice provided to FLEXGROUND by purchaser of a warranty claim. Reasonable written notice is defined as written notice received thirty (30) days from the date that the defect was either discovered or should have been discovered with reasonable diligence. Non-compliance with any of the above contingencies shall nullify the warranty in whole.
